

Effective September 1, 2025, **S.B. 1667 Section 2 amended Texas Code of Criminal Procedure 55A.253(c)** to require that the district clerk maintain on their website a list of law enforcement agencies and entities which maintain criminal records. The District Clerk is NOT responsible for ensuring that the list is complete or applicable to every expunction petition.
